**TERMS & CONDITIONS**

Kismet Limousine Inc. will strictly enforce State and Federal Laws and will maintain that no alcoholic beverages can be consumed or used by any person not of legal drinking age. All US law enforcements have absolute power to stop any motor vehicle for administrative searches. If contraband is aboard, even in negligible quantities without the chauffeur’s knowledge, they can seize and forfeit this vehicle to a local government agency. All law enforcement agencies are aggressively enforcing this policy. Therefore, no person should bring contraband aboard vehicles that are owned or operated by Kismet Limousine Inc. Kismet Limousine will not be responsible for any injuries that may occur due to horse play while the vehicle is in motion or at a standstill. At the signer(s)’s own responsibility and liability, champagne should be provided by the signer(s) and they must have a sales receipt by law, also signer(s) have to make sure that no minors will consume the champagne. Complimentary water, soda and ice will be supplied by the limousine service. The purchaser(s) /or signer(s) on page #2 of this contract accepts all responsibility and any liability for his or her guests at all times, for anyone that gets hurt, gets sick, or damages any part of the limousine during the limousine rental period.

Kismet Limousine Inc. recommends any and all any personal valuables be removed from the vehicle when unattended. We will not be held responsible for any lost, stolen or damaged articles.

Kismet Limousine reserves the right to terminate this or any other contract for noncompliance of the above requests, especially if renters do not follow chauffeurs request in order to obey the rules in this contract. No smoking is allowed in our vehicles. Any deposits (cash, checks, or credit card authorization) will be non-refundable for any reason, if any cancellation occurs from renter’s side. The renter’s in this contract states that she/he is the authorized purchaser for this rental contract, the authorized cardholder for the given credit card, responsible and liable for payment of the total amount, by cash, credit card, check or money order. Checks are only accepted 20 days prior to the reservation date for any remaining balance. No checks or business checks will be accepted at the time of pick up.

As with all contracts, the rental contract between the mentioned person as renter and Kismet Limousine is made with the information and the terms given to us. All of the given information from the renter is binding and cannot be changed without Kismet Limousine's acceptance. If the contract is cancelled or accepted after it is signed, Kismet Limousine is still authorized to collect the remaining balance in full, if the cancellation takes place 29 days before the event. If the cancellation takes place 30 days or more before the event, Kismet Limousine is allowed to keep the Deposit. We will reserve the said date upon the approval of the purchaser's credit card as per telephone conversation. The credit card holder gives authorization to use the credit card information over the fax/internet. Proof of identity of the purchaser using credit card must be supported by the signed contract/credit card authorization via fax or in person. At time of pick up, we need the actual credit card and state identification of the purchaser that authorizes the transaction for the signed contract. If the customer(s) cannot provide all of the above at the time of pick up, Kismet Limousine will not start the job, as we have no proof of the legal possession of the credit card.

Therefore, the risk of not getting paid will give us the right to cancel. The purchaser(s) is still fully responsible to pay the total amount as he/she failed to provide the above requirements. Contracted price is set contracted pickups, addresses, time and number of passengers. Kismet Limousine rates are billed, including applicable fees such as 7% sales taxes, tolls and 20% gratuity. If you feel that you would like to provide an additional gratuity, it is at your sole discretion.

We are not responsible for lost/not received confirmations when booking via internet. Some clients have spam blockers on and sometimes confirmations don't get through. It is the customer's responsibility to call and confirm their reservation after they booked online. It is of particular importance that the purchaser makes allowances for anticipated delays and adheres to the agreed time schedule.

Kismet Limousine cannot guarantee the availability of overtime. In the event that purchaser wants to change the time of itinerary, they may do so, only if Kismet Limousine can accommodate other clients that booked with Kismet limousine prior to or after the said time. The purchaser(s) further agrees to pay additional charges incurred such as overtime, tolls, parking, etc. If customer fails to show at designated pick up location(No show), he/she are responsible for the full payment. Kismet limousine is not responsible for traffic encountered during the vehicle rental time and any delays caused by directions given to the driver by passengers.

The purchaser authorizes Kismet Limousine to charge any additional charges after they have rendered services to the purchaser's credit card as supplemental charge. A 20% service charge, 7% sales tax and tolls will be added to your total charge. The payment is due at the beginning of the rental time. Customer (s) agrees to have Kismet Limousine get an authorization for the above credit card(on page#2) and amount, for the event stated above. Kismet Limousine is not responsible for items that are left in the vehicle, lost or damage. Kismet Limousine reserves the right to charge a delivery fee for returning lost items if found.

Kismet Limousine guarantees that all our vehicles are constantly checked to keep the highest possible operational standards and eliminate such mechanical failures as much as possible. Kismet Limousine agrees to send the requested vehicle as offered in the contract. We have the right to upgrade the vehicles or switch the vehicles in case of emergency, breakdown, or if vehicles were in accidents. As stated, this will only happen on emergencies, and to upgrade, never downgrade. If no upgrade is available, Kismet Limousine gives the customer the right to downsize the vehicle and received additional discounts if desired. No additional charges will occur on customer side if upgrade is made

without customer request. If switching occurs in the same category, or upgrades are made, it will not affect the contract and/ or payment of contract.

Customer(s) therefore accepts that replacement limousine may be substitute if contracted limousine becomes unavailable for any reason. If any of our above guarantees or contracted terms cannot be met due to conditions beyond our control, including weather, accidents and any other acts of God, included but not limited to traffic congestion, accidents, weather delays, road closures, etc; we will use our best efforts to notify the customer of these conditions, resulting delays or changes. Air conditioning is not guarantees on any/ all antique cars. Kismet Limousine reserves the right to terminate any reservation without refund, if the operator or the Dispatcher on duty feels that the renter and/or party of the renter is putting the operator or the mode of transportation or the renter/and/or party of the renter in danger of injury. Or, if the renter and/ or party of the renter are in possession of any illegal material and /or substance, this service will be cancelled without refund. This is without exception.

Signer(s) , Bride and Groom or the purchaser(s) of this contract accepts all responsibility for the entire guess party, prom party or bridal party and or whomever would travel in the limousine during the rental period. Any damage to the vehicle due to carelessness or unnecessary roughness will be the sole responsibility of the signer(s) or purchaser(s) of this contract.

In case of non-payment or any disputes of charges resolved from things like damaged car or overtime, etc, I/ We agree and fully authorize the charges to be put on my credit card provide above. I/We understand these terms and conditions and fully agree to them by signing below.
